### **CONDITIONS FOR SCHOLARSHIP:**

- 1 This scheme shall be applicable for the candidates seeking admission to first year in the Academic Year 2024-25. Any students who have been admitted in previous years are not entitled under this scheme.
- 2 The candidates must submit an Official application within 15 days after declaration of board results for UG courses and Graduation results for PG Courses.
- 3 All Scholarships applications received will be placed before the Scholarship Grants Committee.
- 4 A candidate is allowed to avail only ONE type of scholarship.
- 5 Domicile candidate have to submit proof of residence like Aadhar card, Electric Bill, Voter Card, Indian Passport, Ration Card or Gas Connection copy.
- 6 Student with gap in education are not eligible for scholarship.
- 7 Merely, satisfying the eligibility criteria does not entitle a student sanction of scholarship, in case of claim by more than one student. Decision of the university will be final and cannot be challenged in the court of law.
- 8 Increase and decrease in number of scholarship and percentage of scholarship lies at the discretion of the University.
- 9 The University reserves the right to withdraw or change or cancel any scholarship scheme without prior intimation. In such cases, the student will be required to pay regular applicable fees. The University reserves its right to terminate these schemes at any stage.
- 10 University decision shall be final and binding.
